1. Purpose

1.1 In analysing resource development proposals such as coal mining, natural gas proposals and other mining activities, even at the exploration licence (EL) phase, there will be factors that require consideration, having regard to the overall community interest.

While not all of the considerations listed in this Policy will be relevant to every proposal, it is important that such matters are identified and the relevance considered as a check list for Council's benefit when making a judgement on such proposals.

2. Scope

2.1 This policy provides Council with general guidance of relevant issues that should be considered when establishing a position on resource development proposals.

4. Policy Principles

4.1 Gunnedah Shire Council seeks to ensure that sound environmental practices exist in all levels of resource development, within the Gunnedah LGA and adjoining LGA's and effective community consultation and awareness is followed in the various development processes in order to achieve balanced and sustainable outcomes that adequately contribute to the local economy and community whilst having regard to the principles of ecologically sustainable development.

5. Policy Statement

5.1 General

In analysing its overall position on a resource development or potential resource development proposal, Council shall be mindful to the following matters.

- Strategic context of the proposal
- Identification and management of issues
- Impact analysis and mitigation measures
- Adequacy and availability of base data to justify a proposal
- Potential alternative development options
- Socio-economic considerations
- Infrastructure implications
- Natural resource implications
- Environmental implications
- Ecological sustainability of the proposal

5.2 Specific

In considering proposal, regardless of status Council may have regard to the following critical areas:

- Transportation matters
- Soil and geological issues
- Agricultural implications
- Water issues (General)
- Groundwater impacts
- Surface Water impacts
- Air quality issues
- Noise, vibration and blasting issues
- Flora and fauna issues
- Aboriginal heritage matters
- Other heritage issues
- Visual impacts
- Potential hazards
- Social and health concerns
- Economic issues
- Community issues
- Cumulative impacts
- Environmental impact
- Environmental management
- Consultation and engagement issues
- Infrastructure considerations
- Rehabilitation

In establishing its position on a resource development proposal Council may consider issues outside the scope of those listed in this policy given the localised or broader context of such analysis due to the specific or unique circumstances, as determined by Council, of the individual proposal.

5.3 Compensation Fees

When assessing Access and Compensation Arrangements (ACA) submitted by holders of Exploration Licences prospecting for resources the following minimum compensation fees shall be considered.

Environmental Studies	\$100.00	Per day when drill site is accessed		
Seismic Survey	\$600.00	Per day during term of survey work		
Legal Advice	\$600.00	Minimum reimbursement in obtaining legal advice in relation to arrangement

All fees are GST exclusive

Compensation for a drill site occupation shall apply whilst a drill rig is on each individual site and until the site is decommissioned, all plant removed and site rehabilitated.
