

## Weed Biosecurity Property Inspections

### FACT SHEET

LAST UPDATED 5/6/23

The Biosecurity Act 2015 establishes a framework for the prevention, elimination and minimisation of biosecurity risks across the State. The overriding message delivered by this Act is that weed management is a shared responsibility, requiring a combined effort from all stakeholders including government, industry and the community.

Weeds are predominantly plants that occur in environments outside of their natural distribution. Priority target weeds may be agricultural (where they compromise sustainable farming) or environmental weeds that invade and threaten natural ecosystems and compete with native flora. Environmental weeds reduce biodiversity, seriously impacting native animals and damage fragile ecosystems.

Gunnedah Shire Council undertakes routine private property inspections throughout the local government area to identify priority weeds and provide assistance and information to landholders to help them comply with the *Biosecurity Act 2015* ("the Act").

#### FREQUENTLY ASKED QUESTIONS

**Q. Can I be present during the inspection?**

**A.** Yes. Not only do you have the right to be present during the inspection, wherever possible, Council encourages your attendance or that of your representative.

**Q. How long will the inspection take?**

**A.** This depends on how large the property is and how easy it is to access the property.

**Q. Can I stop the inspection from taking place?**

**A.** No, Property inspections to identify priority weeds are by law. Council has suitably qualified staff who will conduct the inspection.

**Q. What happens if I have priority weeds growing on my property?**

**A.** After the inspection, a report, together with informative documentation and any action that may be required will be forwarded to the registered landowner/ratepayer/occupier. If required, a re-inspection will be scheduled to determine whether adequate control measures have been undertaken, to meet biosecurity requirements.

**Q. What if I can't undertake the work required or need more time?**

**A.** Council staff are available to confidentially discuss any issues you may have, and are there to be of assistance in dealing with weed related matters.

**Q. What if I don't agree with the information on the report?**

**A.** You should contact a Weeds Biosecurity Officer to discuss any concerns you have.

**Q. What happens if my property is rented or leased?**

**A.** You should notify your agent or the tenants that a property inspection is being programmed, or alternatively, you can call Council with the details so contact can be made with the tenants. Any final inspection report will be sent to the registered landowner/ratepayer unless the occupier is also entitled to a copy.

**Q. What happens if my gate is locked and the inspection couldn't proceed?**

**A.** An alternative inspection date will be scheduled. The Weeds Officer will attempt to contact you verbally and the property will be inspected on a separate occasion. Weed Biosecurity Officers are legally permitted to cut locks, but will only do this if the landowner refuses to co-operate. It is an offence to obstruct or hinder an officer/Inspector trying to exercise a function of the Act.

**Q. Is there any cost involved?**

**A.** No, not for an initial inspection. A fee may be charged for any subsequent re-inspections where a land owner has failed to comply with weed control requirements given under the Act. More specific information is available in Council's adopted Fees and Charges.

**Q. What if I don't clean up my weed problem?**

**A.** Under the *Biosecurity Act 2015* "persons generally" have a biosecurity duty to ensure that any biosecurity risk is prevented, eliminated or minimised – so far as is reasonably practicable and proportionate to the priority of the threat. Heavy fines apply for offences committed under the Act.

### THINGS YOU NEED TO DO ON THE DAY OF THE INSPECTION

- Be sure your dogs are securely tied up. This will assist the officer to conduct the inspection safely. The weeds officer will approach a residential building to meet you first.
- Be sure all gates are unlocked so the officer can gain access.
- Should you need to lock a gate for security reasons you will need to make arrangements prior to the inspection to have the gate unlocked, or the key to be left at an agreed collection point.
